Sir,

1. The Board of Directors of the company at its meeting held on February 20, 2020 appointed me as a Scrutinizer for scrutinizing the postal ballot voting including e voting process.

2. I submit my report as under:

The Company has completed the despatch of postal ballot forms along with postage prepaid business reply envelope on February 29, 2020 by permitted mode to those members who have not registered their email ids with the Company / RTA and completed the despatch of postal ballot notice by email on February 29, 2020 to those members who have registered their email ids with the Company / RTA.

The notice of postal ballot (physical) was sent to the members whose name(s) appeared on the Register of Members / list of Beneficial Owners as received from National Securities Depository Limited (NSDL) / Central Depository Services (India) Limited (CDSL) as on Monday, February 24, 2020.

2.1 Particulars of votes cast through electronic means have been entered in the register separately maintained for the purpose. I have been informed by Kfin Technologies Private Limited that they did not receive any postal ballot form up to 5.00 PM of March 30, 2020 being the last time and date fixed by the Company for the receipt of postal ballot forms.

2.2 Since there was no postal ballot form received, the question of keeping them under my safe custody before commencing the scrutiny does not arise.

2.3 The votes cast through electronic means were unblocked on March 30, 2020 at 5.01 P.M.

2.4 Votes cast through electronic means were scrutinized and the shareholding was matched/confirmed with the Register of Members of the company / list of beneficiaries as on Monday, February 24, 2020.

2.5 Votes cast through electronic means up to 5.00 PM of March 30, 2020 being the last time and date fixed by the company for voting through electronic means were considered for my scrutiny.

2.6 No envelope containing postal ballot form was received after March 30, 2020 up to the date of this report.

2.7 No envelope containing postal ballot forms were returned undelivered up to the date of this report.

2.8 I did not find any defaced or mutilated ballot paper.

4. I have emailed all the e-registers and records relating to e-voting for the safe custody to the Company Secretary.
