We wish to inform that pursuant to the Scheme of Amalgamation and Arrangement between GMR Holdings Private Limited (the existing Holding Company of GMR Infrastructure Limited, Transferor Company 1) and GMR Projects Private Limited (Transferor Company 2) with GMR Enterprises Private Limited (Transferee Company) approved by the Hon'ble High Court of Madras vide its Order No. 8471/16 dated July 06, 2016, the Company has received disclosure dated August 12, 2016 in the prescribed format under Regulation 7(2)(a) of the Securities Exchange Board of India (Prohibition of Insider Trading) Regulations, 2015 from GMR Enterprises Private Limited (GEPL, Transferee Company which has substituted the existing Holding Company i.e., GMR Holdings Private Limited), forming part of promoter/promoter group of the Company.

Henceforth, GMR Enterprises Private Limited is the Holding Company of GMR Infrastructure Limited, with effect from the Effective Date of said Amalgamation and the shares held by GMR Holdings Private Limited in GMR Infrastructure Limited shall be in the possession of GMR Enterprises Private Limited without any further action.
