Sub: Intimation in respect of the Supreme Court Order confirming the finality of Nagpur Airport Concession rights in favour of GAL

Ref: Intimation under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015

This is in continuation of our letters dated October 01, 2018, March 09, 2019, March 20, 2020, August 20, 2021 and May 10, 2022 this is to inform you that the Hon'ble Supreme Court of India vide its Order dated September 27, 2024, declined to exercise jurisdiction to interfere with its judgement dated May 09, 2022. The Supreme Court judgement upheld the judgement of the Hon'ble Nagpur Bench of the Bombay High Court quashing and setting aside the Letter dated March 19, 2020 issued by MIHAN India Limited annulling the bidding process for the Nagpur Airport, and thus, directed MIHAN India Limited to execute the Concession Agreement with GMR Airports Limited / its Special Purpose Vehicle.

The Hon'ble Supreme Court has disposed of the Curative Petitions filed by Union of India and Airport Authority of India by recording the submission of the Ld. Solicitor General of India, that the said Curative Petitions were not pressed before the Hon'ble Supreme Court by the Petitioners on account of no valid grounds under the curative jurisdiction to challenge the earlier ruling of court in its order dated May 09, 2022.

With all the legal hurdles finally concluded, the Authorities are required to execute the Concession Agreement at the earliest for the Nagpur Airport with GMR Airports Limited / its Special Purpose Vehicle.

GMR had emerged as the highest bidder in the tender process conducted by MIHAN India Limited for the Nagpur Airport in 2019. The Letter of Award was issued to GMR in March 2019. However, Government of Maharashtra decided to cancel the tender process in March 2020 and MIHAN India Limited issued a Letter annulling the bid process, which was set aside by the Hon'ble Nagpur Bench of the Bombay High Court in August 2021 and the said judgement was upheld by the Hon'ble Supreme Court vide its judgement dated May 09, 2022. The said Order was challenged by the Authorities seeking for a reconsideration of the judgement through a review petition and later curative petition that was ultimately disposed-off by Hon'ble Supreme Court by its order dated September 27, 2024.
